

## WINNEBAGO COUNTY ORDINANCE NO. #28

An Ordinance Regulating Motor Vehicles and Law of the Road in Winnebago County, Iowa, in accordance with Section 331.302, Code of Iowa.

Section I. Any person who shall willfully fail or refuse to comply with any lawful order of a police officer or direction of a fire department officer during a fire shall be guilty of a misdemeanor punishable as provided for in Sections 903.1 and 903.1(1)(a), Code of Iowa.

Section II. The following Sections of the Iowa Code and amendments are hereby adopted by reference and any person who fails to abide by or violates the provisions of this Ordinance shall be guilty of a simple misdemeanor punishable as provided for in Sections 903.1 and 903.1(1)(a).

1. 321.1, 321.20B, 321.32, 321.37, 321.174, 321.174A, 321.180B, 321.189, 321.193, 321.194, 321.218 and 321.219 through 321.224 - definitions, proof of security against liability, display of registration, plates, license to drive, and unauthorized practices.
2. 321.229 through 321.235 - obedience to a police officer and responsibility of public officers, emergency vehicles, bicycles and other vehicles to obey traffic regulations.
3. 321.256 through 321.260 - traffic signs, signals and markings, including right or left turns on red.
4. 321.262 through 321.266 and 321.268 - accidents and accident reporting.
5. 321.275 - operation of motorcycles.
6. 321.277, 321.277A, 321.278, 321.284 through 321.288,

- 321.290, 321.291, 321.294 and 321.295 - reckless driving, careless driving, drag racing, open container, speeding restrictions and control of vehicle.
7. 321.297 through 321.310 - driving on right side of roadway, overtaking and passing.
  8. 321.311 through 321.318 - turning and starting, signals on turning and stopping.
  9. 321.319 through 321.324 - right of way.
  10. 321.325 through 321.334 and 321.340 - pedestrian rights and duties.
  11. 321.341 through 321.344B and 321.353 - special stops required.
  12. 321.354 through 321.360 - stopping, standing and parking.
  13. 321.362 through 321.371 - unattended vehicles, obstructing driver's view, preventing contamination of food, coasting, following fire apparatus, crossing fire hose, and putting debris on highway, removing injurious material, cleaning wrecks.
  14. 321.384 through 321.409, 321.415, 321.417 through 321.423 - lighting equipment.
  15. 321.430 through 321.446, 321.449 and 321.450 - brakes, horns, sirens, mufflers, wipers, mirrors, tires, windows, safety belts, and special markings for transporting explosives.
  16. 321.452 through 321.463, 321.465 and 321.466 - size, weight and load.
  17. 321.482, 321. 485, 321.487 and Chapter 805, Code of Iowa - citations, penalties and appearances.

Section III. Effective Date. This Ordinance shall become effective after its final passage, approval and publication as provided by law.
