Resolution to fix a date for public hearings on a loan agreement and on a pledge of tax increment revenues

WHEREAS, the Board of Supervisors (the "Board") of Winnebago County, Iowa (the "County") has established the Winnebago County UR-2 Economic Development Urban Renewal Area (the "Urban Renewal Area") and has adopted an ordinance providing for the division of revenues produced from taxable property within the Urban Renewal Area; and

WHEREAS, the Board proposes to enter into a loan agreement (the "Loan Agreement") in a principal amount not to exceed \$5,500,000 pursuant to the provisions of Sections 331.402, 331.441 and 403.9 of the Code of Iowa for the purpose of paying the cost, to that extent, of planning, undertaking, and carrying out projects in the Urban Renewal Area consisting of improvements to county roads and the Board proposes to institute proceedings to enter into the Loan Agreement by causing a notice of such proposal to be published, including notice of the right to petition for an election, pursuant to Section 331.443; and

WHEREAS, pursuant to the provisions of Chapter 403 of the Code of Iowa, the Board proposes to pledge certain incremental property tax revenues to be derived from the Urban Renewal Area (the "Tax Increment Pledge") in order to provide additional security for the County's obligations to be incurred under the Loan Agreement; and

WHEREAS, it is necessary to fix a date of meeting of this Board at which it is proposed to take action to enter into the Loan Agreement and to consider approval of the Tax Increment Pledge and to give notice thereof as required by law;

NOW, THEREFORE, It Is Resolved by the Board of Supervisors of Winnebago County, Iowa, as follows:

The Board of Supervisors of Winnebago County, Iowa, will meet on the 19<sup>th</sup> day of December, 2011, at the Winnebago County Courthouse, Forest City, Iowa, at 10:00 o'clock a.m., for the purpose of holding a hearing and taking action to enter into a loan agreement (the "Loan Agreement") in a principal amount not to exceed \$5,500,000 for the purpose of paying the cost, to that extent, of planning, undertaking, and carrying out projects in the Winnebago County UR-2 Economic Development Urban Renewal Area consisting of improvements to county roads.

WHEREAS, the City of Forest City has adopted the original Forest City Prairie View Economic Development District Urban Renewal Plan (the "Original Urban Renewal Plan") for the original Forest City Prairie View Economic Development District Urban Renewal Plan Area (the "Original Urban Renewal Plan Area") in 2004, Amendment No. 1 to the Forest City Prairie View Economic Development District Urban Renewal Plan in 2006, and Amendment No. 2 to the Forest City Prairie View Economic Development District Urban Renewal Plan in 2009 (together the "Urban Renewal Plan"); and

WHEREAS, the Original Urban Renewal Plan provides for the provision of public improvements relating to housing and residential development in the City of Forest City, including the installation, construction and reconstruction of streets, parking facilities, open space areas and other substantial improvements ("Project"); and

WHEREAS, the City adopted Ordinance No. 649 for the Project 1 TIF Area within the Original Urban Renewal Plan Area and certified debt on said Project 1 TIF Area in 2006.

WHEREAS, Iowa Code Section 403.22(5) limits the division of revenue under Iowa Code Section 403.19 to ten years for housing projects, unless the municipality undertaking the project has a population of under 15,000 persons and obtains approval from the governing bodies of all other affected taxing districts to extend the division of revenue for up to five years; and

WHEREAS, the City of Forest City has a population of under 15,000; and

WHEREAS, the City has requested that the other affected taxing districts involved, consisting of the North Iowa Area Community College, Forest City Community School District, the County of Hancock, and the County of Winnebago, allow the division of revenue for the Project 1 TIF Area within the Original Urban Renewal Area to be extended to fifteen (15) years:

### NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

Section 1. Pursuant to Iowa Code Section 403.22(5) all affected taxing districts have, by resolution of their governing bodies, approved the extension of the division of revenue under Iowa Code Section 403.19 in the Project 1 TIF Area governed by Ordinance No. 649 of the Original Urban Renewal Area for the City of Forest City, Iowa, for projects involving the provision of public improvements related to housing and residential development for a total of fifteen (15) years, beginning with the second fiscal year after the year in which the municipality first certified to the county auditor the amount of any loans, advances, indebtedness, or bonds which qualified for payment from

the division of the revenue in connection with the Project. In this case, the last year for the division of revenues (calculated as ten years beginning with the second fiscal year after the City's 2006 debt certification) is extended from fiscal year 2017/2018, for an additional five years until fiscal year 2022/2023 for the Project 1 TIF Area within the Original Urban Renewal Area.

Section 2. The undersigned officials affirm they are duly authorized to execute this agreement on behalf of the party for which they are signing.

Section 3. This Agreement may be executed in any number of counterparts, each of which shall constitute one and the same instrument.
