## Resolution Taking Additional Action on Loan Agreement and TIF Revenue Pledge

WHEREAS, the Board of Supervisors (the "Board") of Winnebago County, Iowa (the "County") has created the Winnebago County UR-2 Economic Development Urban Renewal Area (the "Urban Renewal Area") and has adopted an ordinance providing for the division of incremental property tax revenues in the Urban Renewal Area; and

WHEREAS, the Board has heretofore proposed to enter into a loan agreement (the "Loan Agreement") in a principal amount not to exceed \$5,500,000 pursuant to the provisions of Sections 331.402, 331.441 and 403.9 of the Code of lowa for the purpose of paying the cost, to that extent, of planning, undertaking, and carrying out projects in the Urban Renewal Area consisting of improvements to county roads and, in lieu of calling an election therefore, the County has instituted proceedings to enter into the Loan Agreement by causing a notice of such proposal to be published, including notice of the right to petition for an election, and no such petition has been filed; and

WHEREAS, pursuant to the provisions of Chapter 403 of the Code of Iowa, the Board also proposed to pledge certain incremental property tax revenues in an amount not to exceed \$5,500,000 to be derived from the Urban Renewal Area (the "TIF Revenue Pledge") in order to provide additional security for the County's obligations to be incurred under the Loan Agreement; and has published notice of such proposal and held a hearing thereon;

NOW, THEREFORE, It Is Resolved by the Board of Supervisors of Winnebago County, Iowa, as follows:

- Section 1. The Board hereby determines to enter into the Loan Agreement in the future and orders that the Bonds be issued at such time in evidence thereof. The Board further declares that this resolution constitutes the "additional action" required by Section 331.402 of the Code of Iowa.
- Section 2. The Board hereby determines to secure the Bonds with the TIF Revenue Pledge and declares that this resolution constitutes the "additional action" required by Section 403.9(3) of the Code of Iowa.
- Section 3. All resolutions and orders or parts thereof in conflict with the provisions of this resolution, to the extent of such conflict, are hereby repealed.
- Section 4. This resolution shall be in full force and effect immediately upon its adoption and approval, as provided by law.
