On a motion by Stensrud and seconded by Wubben the Supervisors moved to approve the bill for DD 84. All voted aye. Motion carried.

On a motion by Stensrud and seconded by Wubben the Supervisors moved to approve the bill for DD 57 Lat 19. All voted aye. Motion carried.
