### Minutes of Winnebago County E911 Service Board Public Budget Hearing and Regular Business Meeting Meeting date: Feb 11, 2013

# **Election of Officers:**

Mr. Thomas suggested the board keep the officers the same; however Mr. Jenson the former vice chair is no longer a member. After discussion, Mr. Durby was nominated as vice chair. Mr. Davis asked if there were any other nominations, there were none. Mr. Thomas made a motion to elect Mr. Davis as Chair of the Service Board and Mr. Durby as the Vice Chair. # E911 Budget 2013/2014:

Shieldware maintenance contract was the largest increase just over \$9,000, and a monthly fee increase for selective routing of 911 calls. Ms. Ackerman further advised the initial cost of Shieldware will be paid off in fiscal year 2013/2014 which was \$23,700 annual cost over 3 years. Mr. Davis asked for comments from the public. No members of the public were heard from. Mr. Armstrong made a motion to close the meeting to the public, Mr. Thomas offered a second. All voted aye, motion carried. Meeting closed to public.

Mr. Armstrong made a motion to adopt the E911 Budget for fiscal year 2012/2013. Mr. Durby offered a second. All voted aye, motion carried.
