If 911 surcharge funds are used to equip the public safety agencies, law, fire and ems, this will save those departments from having to ask the cities for the money to purchase them. He advised this will take a few years but the funds should be there in the future to make these purchases.

Mr. Durby asked if there were any other comments on the budget. Hearing none he asked for a motion to close the public hearing. Mr. Ostrander made a motion, Ms. Blocker offered a second, all voted aye, motion carried.
