The Winnebago County Board of Supervisors met in session at 9:00 A.M. July 17, 2018 adjourned from July 10, 2018.

Motion made by Stensrud and seconded by Jensvold that the following resolution be adopted.


WHEREAS, there are now outstanding warrants and claims against the following Drainage Districts and there being insufficient funds to take care of these accounts of the Drainage Districts.


