The Winnebago County Board of Supervisors met in session at 9:00 A.M. March 17, 2020 adjourned from March 10, 2020.

Present: Supervisors Jensvold, Stensrud, and Durby

Absent:

On a motion by Stensrud and seconded by Durby the Supervisors moved to approve the minutes for the March 10, 2020 Board Meeting and approve the Agenda for March 17, 2020. All voted aye. Motion carried.

On a motion by Durby and seconded by Stensrud the Supervisors moved to open a Public Hearing for the Winnebago County FY 2020-2021 Budget. All voted aye. Motion carried. At the meeting were Supervisors Jensvold, Stensrud, and Durby, Kris Oswald, Deputy Auditor, David Peterson, Sheriff, Mike Droessler, Steve Lillquist, Melissa Michaelis, Kris Colby, Recorder, and Andy Buffington. There was no discussion. On a motion by Stensrud and seconded by Durby the Supervisors moved to close the Public Hearing. All voted aye. Motion carried.

On a motion from Durby and seconded by Stensrud the Supervisors moved to approve the Winnebago County FY 2020-2021 Budget. All voted aye. Motion carried.

Julie Sorenson and Allison Rice from Public Health updated the Supervisors on the Covid-19 virus. On a motion from Durby and seconded by Stensrud the Supervisors moved to close Winnebago County Public Facilities until further notice. The Courthouse will leave the West door by the elevator open for the Clerk of Court. All voted aye. Motion carried.

Scott Meinders, Engineer discussed secondary road matters including the road conditions.

Kris Oswald, Drainage Clerk discussed drainage district matters.

There was discussion on a retirement policy. After much discussion the Supervisors agreed to not have an early retirement program at this time.

On a motion by Durby and seconded by Stensrud the Supervisors moved to approve the following Auditor's transfers: #3784 from Rural Basic to Secondary Roads for \$21,718.38; #3785 from Rural Basic to Winnebago County Fair Association for \$819.74; and #3786 from General Basic to Winn-Worth Betco for \$13,206.25.
