On a motion by Stensrud and seconded by Durby the Supervisors moved to approve the minutes for the March 17, 2020 Board Meeting and approve the Agenda for March 24, 2020. All voted aye. Motion carried.

On a motion from Durby and seconded by Stensrud the Supervisors moved to approve Change Order #6 for Randall Construction. All voted aye. Motion carried.

On a motion by Durby and seconded by Stensrud the Supervisors moved to set a bid letting date for DD 11 Main Tile Improvement for April 21, 2020 at 10:00 A.M. All voted aye. Motion carried.

On a motion from Stensrud and seconded by Durby the Supervisors moved to approve a Disaster Emergency Declaration. All voted aye. Motion carried.
