WHEREAS, the contributions and sacrifices of those who served in the Armed Forces have been vital in maintaining the freedoms and way of life enjoyed by our citizens; and

sacrifices to preserve freedom by displaying green lights in a window of their place of business or residence from November 4-11, 2025.
