YOU AND EACH OF YOU are hereby notified that there is now on file in the Office of the Auditor of Winnebago County, Iowa, the report from Jacobson-Westergard, certifying that Larson Contracting, Iowa, has completed to the satisfaction of said engineer, and in accordance with the proposal, specifications and contract, all work and obligations required in Drainage District 21, 68-136, 68-136 Lat 2, in Winnebago and Kossuth Counties, Iowa. That said engineer recommend that said company be paid the full balance due it under said contract and that the bond of said company be released.

YOU ARE FURTHER NOTIFIED that the Board of Supervisors of Winnebago County, Iowa, acting for and in behalf of said Drainage District, has ordered hearing upon said report and recommendations to be held **on June 23, 2020 at 9:30 A.M.** in the Supervisor's Room in the **Winnebago County Courthouse, Forest City, Iowa.**

YOU ARE FURTHER NOTIFIED that any interested party having a claim for damages arising out of completed repairs shall file said claim with the Board of Supervisors of Winnebago County at or before the time fixed for hearing on the completion of the contract, which claim shall not include any claim for land taken for right-of-way or for severance of land. The filing of said claim with the Winnebago County Auditor at or before the time fixed for hearing shall be deemed filed with the Board of Supervisors. At said time and completion of said contract, and shall also hear and determine all claims for damages, which may have been filed.

If you have a farm tenant for your land, please notify the tenant of this notice so they may file claims for crop damages, if any.

YOU ARE FURTHER NOTIFIED that this notice and the reference herein to objections and claims for damages and final settlement is in compliance with Section 468.101, Section 468.102, and Section 469.103 of the Code of Iowa.

YOU ARE FURTHER NOTIFIED that unless you appear and object thereto, the report of said engineers and the work of said contractor will be accepted and approved; that the balance due said contractor will be ordered paid and the bonds of said engineers and said contractor be released and the sureties thereon will be exonerated at the time and place above stated.
